Ontario Sailing owns several Martin 16's and Access Dinghy's for the purpose of lending to clubs, groups, and organizations to help them start accessible sailing programs. Boat loans/leases will be granted based on program location, how the boat will be used, and availability of boats. Ontario Sailing requires a Security Deposit in order to lend one of our boats. Please see the 2006 Fee Schedule Below.

A club or organization can borrow a boat for 1 year for just the cost of the damage deposit. To make use of the boat for 2 or more years the club/organization must pay the damage deposit, insurance premiums and the lease fees. (See 2006 Fee Schedule Below)

All Fees are per annum and are subject to GST and PST, except for the damage deposit, which is only paid once during the loan/lease period and is not subject to Tax.

Damage Deposits:

Access Dinghy 2.3 and 303 - \$500.00
Martin 16 Sloop - \$1,000.00

Lease Fees:

Access Dinghy 2.3 - \$600.00 + 7% GST & 8% PST
Access Dinghy 303 - \$680.00 + 7% GST & 8% PST
Martin 16 Sloop - \$1,500.00 + 7% GST & 8% PST

Insurance Premiums:

Access Dinghy 2.3 - \$230.00 + 7% GST & 8% PST
Access Dinghy 303 - \$320.00 + 7% GST & 8% PST
Martin 16 Sloop - \$930.00 + 7% GST & 8% PST
