1. **RULES:** The regatta will be governed by the 2005-2008 International Yacht Racing Rules; the prescriptions of U S Sailing; the Access Dinghy Class Rules (except as altered by the Sailing Instructions), and the Special Olympics Summer Sports Rules: Sailing (download from website, [www.specialolympics.org](http://www.specialolympics.org) ).
2. **CLASSES:**  
Monohull: Access Dinghy 2.3 (single and double), 303 (single and double).  
Multihull: Hobie Wave
3. **SCHEDULE OF EVENTS:** Subject to change  
Saturday May 6, 2006:  
9am: Skipper's meeting with race times and boats presented.  
10am: Start of first heat  
Last race to end by 5:00 pm.  
6pm: Dinner and Awards
4. **LEVELS OF COMPETITION:** Levels 1 and 2 per the Special Olympic Sailing Rules
5. **REGISTRATION:** Registration is on a first-come first-serve basis. Please return the attached registration form with your entrance fee before April 20, 2006.
6. **FEES:** The regatta entry fee of \$75 per team includes: skippers's meeting, one day of racing, boats, all meals, and awards. (Some groups may have made special arrangements regarding fees. Please contact Sandy Ackley regarding your fees.)
7. **WAIVER OF LIABILITY:** Each competitor must sign a Waiver of Liability to qualify entry.
8. **SCORING:** The Low-Point Scoring System, Appendix A of the racing rules shall apply with a maximum of three races scheduled of which one shall be completed to constitute a series.
9. **SAILING INSTRUCTIONS:** The Sailing Instructions will be available at registration.
10. **ADVERTISING:** This championship is classified as a category C event in accordance with rule 79 and Regulation 20.
11. **COURSES:** The Courses shall be described in the Sailing Instructions, and at the Skipper's meeting.
12. **TROPHIES:** Trophies will be awarded in accordance to Special Olympic standards.
